

RURAL MUNICIPALITY OF LOON LAKE NO. 561

BYLAW NO. 2/2016

A BYLAW OF THE RURAL MUNICIPALITY OF LOON LAKE NO. 561, IN THE PROVINCE OF SASKATCHEWAN, TO AMEND THE NORTH OF DIVIDE PLANNING DISTRICT AGREEMENT

WHEREAS, The Council of the Rural Municipality of Loon Lake No. 561 has Adopted Bylaw No. 10/2015 to enter into an Agreement to be a member of the North of Divide Planning District; and

WHEREAS, The Councils of the Rural Municipality of Beaver River No. 622 and the Rural Municipality of Loon Lake No. 561 have provided notice pursuant to Section 11 of said Agreement to terminate their affiliation in the North of Divide Planning District; and

WHEREAS, The Council of the Rural Municipality of Loon Lake No. 561 does not object to Rural Municipality of Beaver River No. 622 and the Rural Municipality of Loon Lake No. 561 terminating their affiliation in the North of Divide Planning District; and

WHEREAS, said Agreement provides that each affiliated municipality shall prepare and consider a bylaw to amend said Agreement by removing reference to the municipality proposing to terminate its affiliation;

NOW THEREFORE, THE COUNCIL OF THE RURAL MUNICIPALITY OF LOON LAKE NO.561 ENACTS AS FOLLOWS:

1.0 This Bylaw shall be sited as the "Bylaw to Amend the North of Divide Planning District Agreement".

2.0 AMENDMENTS TO PLANNING DISTRICT AGREEMENT


The North of Divide Planning District Agreement, which is attached to and forms part of Bylaw No. 10/2015, is amended as follows:

- A. The clause identifying the parties to the agreement, Section 2, and Section 3(i) shall be amended by deleting reference to "Rural Municipality of Beaver River No. 622" and "Rural Municipality of Loon Lake No. 561".
- B. Section 3 shall be amended by deleting subsections b) and c) in their entirety.
- C. Section 16 shall be amended by deleting the "Rural Municipality of Beaver River No. 622" and "Rural Municipality of Loon Lake No. 561" as parties to the agreement.

3.0 EFFECTIVE DATE

This Bylaw shall come into force and take effect upon receiving the approval of the Minister pursuant to Section 106 of *The Planning and Development Act, 2007*.
