BYLAW NO. 1/2003

A BYLAW OF THE RURAL MUNICIPALITY OF LOON LAKE NO. 561 TO PROVIDE FOR THE PERMANENT CLOSURE OF A CERTAIN STREET.

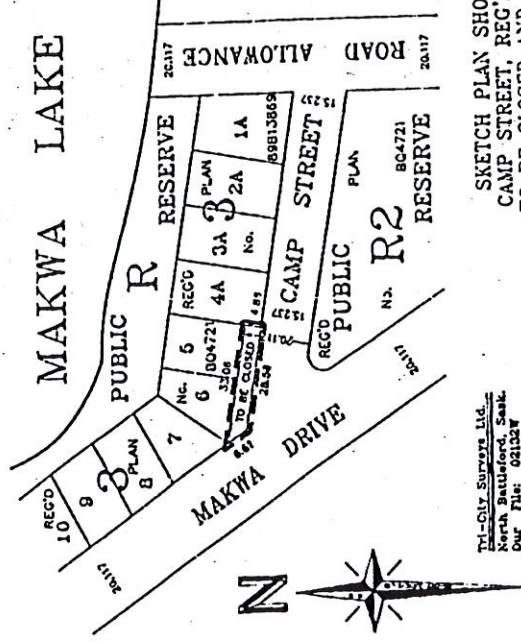
WHEREAS a municipality is allowed to permanently close any street or lane vested in the Crown with the prior written consent of the Minister of Highways and Transportation AND after having given the public notice of the proposed closure;

AND WHEREAS the Minister of Highways and Transportation has consented to, AND Council has given the required public notice of the proposed closure;

THEREFORE, the Council of the Rural Municipality of Loon Lake No. 561, in the Province of Saskatchewan, enacts as follows:

1) To permanently close a portion of the following public highway described as:

*All that portion of Camp Street, Plan BQ4721, described as:
Commencing at the South West corner of Lot 4A, Block 3, Plan 89B13869, thence Westerly on the production Westerly of the Southerly boundary of Block 3, Plan 89B13869 to a point of intersection with the production South Easterly of the South West boundary of Lot 7, Block 3, Plan BQ4721; thence North Westerly to the South West corner of Lot 6, Block 3, Plan BQ4721; thence Easterly to the South East corner of Lot 5, Block 3, Plan BQ4721; thence Southerly to the point of commencement.*
